# **Regulations Concerning Fees**

## **Article 1. Objectives**

The purpose of these Regulations Concerning Fees is to decide essential matters with reference to Acceptance Fees, Monthly Subscription Fees and etc. to be paid by Full Members and Associate Members, as specified in Article 7 of the Articles of Association, and to secure a stable income to provide for the operating expenses arising from carrying out the YC&AC's activities.

## **Article 2. Acceptance Fees and Subscription Fees**

The Acceptance Fees and Subscription Fees, as provided for in Article 3-1 of the By-Laws, shall be as follows:

### **1. Full Members**

#### **(1) Single Member**

- Acceptance Fee JPY 150,000
- Monthly Subscription Fee JPY 19,000
- Deposit JPY 50,000

#### **(2) Family Members**

- Acceptance Fee JPY 300,000
- Monthly Subscription Fee JPY 38,000
- Deposit JPY 100,000

#### **(3) Corporate Single Member**

- Acceptance Fee JPY 200,000
- Annual Fee JPY 300,000

#### **(4) Corporate Family Members**

- Acceptance Fee JPY 400,000
- Annual Fee JPY 600,000

(5) Senior Single Member

- Monthly Subscription Fee JPY 14,000

(6) Senior Family Members

- Monthly Subscription Fee JPY 23,500

(7) Honorary Life Single Members N.A.

(8) Honorary Life Family Members N.A.

## 2. Associate Members

\*\* There will be 36 instalments of the Monthly Acceptance Fee resulting in the total Acceptance Fee paid to be JPY 150,000 for a Term Single Member and JPY 300,000 for a Term Family Member. A Term Member shall automatically transition from an Associate Member to a Full Member (i.e., from Term Single Member to Single Member or from Term Family Member to Family Member, as the case may be) upon completion of payment of the total Acceptance Fee. A Term Member may accelerate completion of payment of the total Acceptance Fee at any time prior to the end of the 36-month instalment payment term by paying the entire remaining outstanding amount in full.

(2) Junior Members

- Monthly Subscription Fee JPY 9,000
- Deposit JPY 50,000

(3) Young Adult Members

- Monthly Subscription Fee JPY 11,000
- Deposit JPY 50,000

(4) Young Professional Members

- Monthly Subscription Fee JPY 13,000
- Deposit JPY 50,000

(5) Affiliate Club Introduced Members

- Monthly Subscription Fee JPY 10,000 - 15,000 (depends on the specific agreement with the said Club)
- Deposit JPY 50,000

**Article 2-3. Transfer Fees**

(1) Honorary Life Single

- Transfer Fee JPY 300,000

(2) Honorary Life Family

- Transfer Fee JPY 300,000 (Per Individual)

(3) Corporate Single

- Transfer Fee JPY 50,000

(4) Corporate Family

- Transfer Fee JPY 50,000 (Per Individual)

**Article 3. Payment of Fees**

Full and Associate Members who have been approved to join the YC&AC shall pay their Acceptance Fees, if applicable, prior to using the facilities.

**Article 4.** The Acceptance Fee, Monthly Subscription Fee and other Fees are non-refundable under any circumstance.

**Article 5.** A Member who has resigned shall be liable for the Acceptance Fee upon rejoining. Such ex-Member may be given the option of paying the total amount of the Monthly Subscriptions from the date of resignation to the date of rejoining instead of paying a new Acceptance Fee.

**Article 6.** Members shall be informed of any changes in Acceptance or Monthly Subscription Fees in writing at least 30(thirty) days prior to the change taking effect.

**Article 7.** Monthly Subscription Fees shall be due for payment before the twentieth (20th) day of the month in which the accounts are sent. Members whose accounts are unpaid within 30 (thirty) days of the deadline shall have their names posted on the YC&AC Notice Board and shall incur commission of JPY1,000 plus 2(two)% percent of the overdue amount, per month, for each month further overdue as the penalty.

#### **Article 8. Use of Fees**

More than 50(fifty)% of the Subscription Fees specified in Article 2 shall be used for the public benefit activities of the YC&AC, and any remainder shall be applied to activities for the mutual benefit and operating expense.

#### **Article 9. Amendments**

These Regulations Concerning Fees and other necessary matters regarding Member fees may be amended by a resolution of the Board of Directors unless a resolution of Full Members at a General Meeting of Members is required by the Articles of Association. Amendments to these Regulations Concerning Fees once approved shall take effect 21 days after posting on the YC&AC's Notice Board. Additional means of notifying Members may also be used. A copy of any amendments to these Regulations Concerning Fees during any fiscal year shall be included with the notification of the applicable annual General Meeting of Members for such fiscal year.

#### **Auxiliary Provisions**
